## GDPR Update

## Event Handler

### Overview

This script is the backbone of the GDPR module and is the script that identifies any GDPR applicable employees and their GDPR breaches. It adds them to the GDPR SQL tables inside the database and works in conjunction with the to-do list script.

### Dependencies

- GDPR to-do list script to enable a manager to action GDPR breaches.
- The GDPR to-do list form event script to enable the to-do list items to be clickable.
- The GDPR Maintenance script to action any GDPR you manually do.

### Operation Example

- The managers will never notice this running. It is ran via an event in the event handler every few hours.

### Configuration

- Assigned via an event handler trigger script event. Recommended to run these every 3 hours.
- Set the values to a very large amount (99 years) to avoid them being triggered if the customer does not want a particular field.
